Heard the learned counsel appearing for the petitioner as well as the learned Additional Public Prosecutor appearing for R1 and R2 and the learned counsel for third respondent.

2.This petition has been filed by the petitioner/husband of the deteneue, P.Ishwarya Devi, daughter of the third respondent, aged about 21 years, directing the second respondent to cause production

of her wife/the detainee, before this Court and to set her at liberty.

3.The alleged detainee P.Ishwarya Devi is present before this Court and her parents are also present in the open Court. On enquiry, the detainee expressed that there is no illegal detention of her by anybody and that she is major and that she is willing to go along with her parents and her parents are also willing to take back their daughter.

4.Recording the statement made by the detainee to the effect that there is no illegal detention, we are of the view that this petition could be closed as nothing further remains to be considered.

5.Accordingly, this petition is closed. It is open to the petitioner to approach the appropriate forum seeking remedy, according to law.
