Habeas Corpus Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of Habeas Corpus calling for the entire records relating to the impugned order of detention passed by the second respondent in C2/9430/2015 dated 18.05.2015 and set aside the same and consequently direct the respondents to produce the detainee Poongavanam aged about 34 years, petitioner's husband now confined at Central Prison, Cuddalore, before this Court and set him at liberty forthwith.

The petitioner, who is the wife of the detenu Poongavanam, S/o.Pakkiri Padayachi, aged about 34 years, has come forward with this petition challenging the detention order in No.C2/9430/2015 dated 18.05.2015 passed by the second respondent against her husband branding him as a "Bootlegger" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner dated 18.05.2015 has been revoked by the Government in G.O. [Rt] No.4154, Home, Prohibition & Excise [XIV] Department dated 03.07.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.

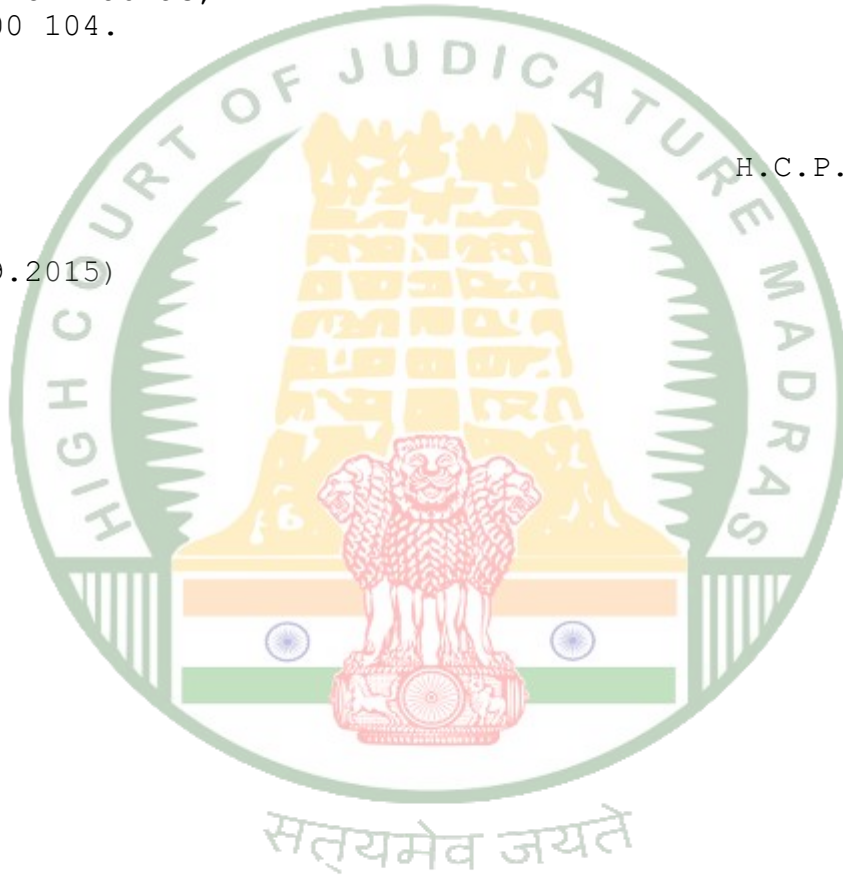
