2. Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the respondents and perused the materials placed on record.

3. In similar cases, namely CrI.OP.Nos.25757 of 2014 and 12596 to 12619 of 2014, this Court has granted similar reliefs to the same petitioner, in respect of other places.

4. Following the earlier orders, this Court directs the respondent police to enquire and give adequate police protection to the petitioner, for erecting transmission tower at Nilgiris District, Ootacamund Municipality, R.S.No.3903/2 in New T.S.No.E-5/11/1,3 bearing Door No.12/J-6, Woodcodd Road, Ooty-643 001, at the cost of the petitioner for a period of eight weeks.

5. Accordingly, this Criminal Original Petition is ordered.
