Habeas Corpus Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of Habeas Corpus to call for the records relating to the detenu's order in C.O.C. No.34/2015, dated 25.05.2015 passed by the second respondent under Tamil Nadu Act 14 of 1982 and to set aside the same and to direct the respondents to produce the petitioner's son Manokaran, S/o.Senji Thevar, aged about 41 years, now confined in Central Prison, Tiruchirappalli, before this Court and to set him at liberty.

The petitioner, who is the mother of the detenu Manokaran, S/o.Senji Thevar, aged about 41 years, has come forward with this petition challenging the detention order in C.O.C. No.34/2015, dated 25.05.2015 passed by the second respondent against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner dated 25.05.2015 has been revoked by the Government in G.O. [Rt] No.4363, Home, Prohibition & Excise [XV] Department dated 15.07.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.

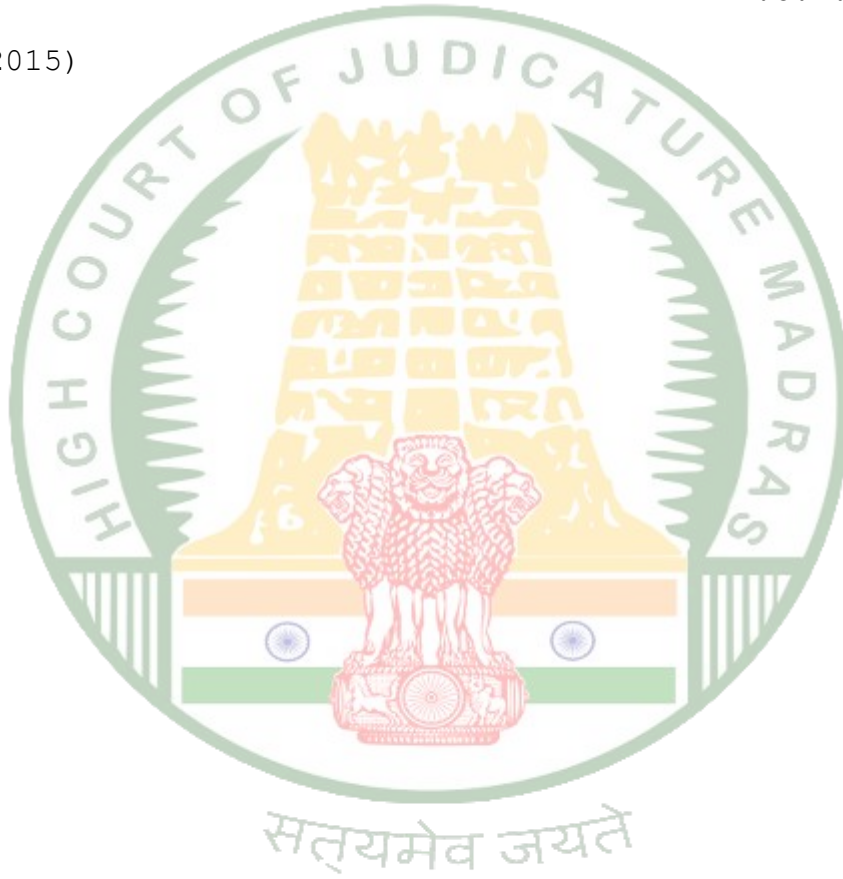
