ORDER

(Order of the Court was made by S.TAMILVANAN, J.)

The petitioner, who is wife of the detenu herein, viz., Pandiyan @ Kozhi Pandiyan, son of Kaliyaperumal, aged 27 years, has come forward with this petition challenging the detention order passed by the second respondent dated 17.01.2015 against her husband branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Piracy Act 1982 [Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner herein dated 17.01.2015 has been revoked

by the Government in G.O. [Rt] No.1771, Home, Prohibition & Excise [XIV] Department dated 09.03.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.

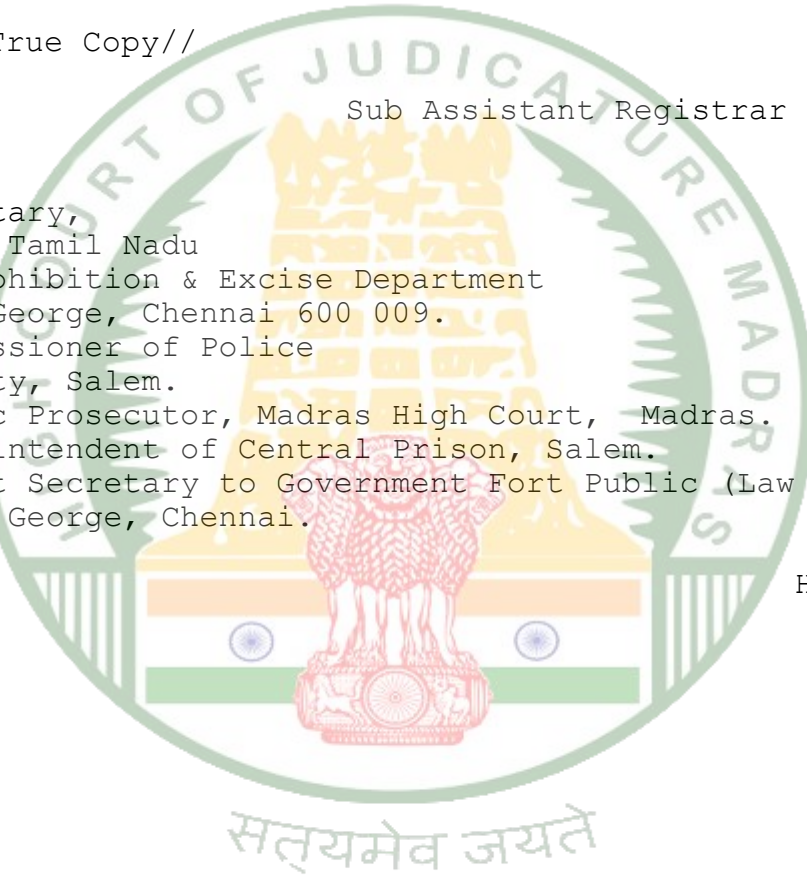
