The petitioner, who is the husband of the detenu, Govindammal, aged 36 yeas, W/o Thulasi, has come forward with this petition challenging the detention order passed by the second respondent made in C3/D.O.No.67/2015 dated 17.07.2015 against his wife branding her as a "Bootlegger" as contemplated under section 2(b) of the Tamil Nadu Act 14 of 1982.

2. Learned Additional Public Prosecutor submits that the order of detention passed by the second respondent as against

the wife of the petitioner dated 17.07.2015 has been revoked by the Government in G.O. Rt No.5626, Home, Prohibition & Excise (IX) Department, dated 04.09.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
