The petitioner, who is the mother of the detenu, Yuvaraj, aged 26 years, S/o Ganapathy has come forward with this petition challenging the detention order passed by the second respondent made in B.C.D.F.G.I.S.S.S.V. No. 56/2015 dated 07.07.2015 against her son branding him as a "GOONDA" as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

Learned Additional Public Prosecutor submits that the order of detention passed by the second respondent as against the son of the petitioner dated 07.07.2015 has been revoked by the Government in G.O. Rt No.5387, Home, Prohibition and Excise (XI) Department, dated 19.08.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
