3. On a perusal of the complaint dated 09.04.2015, it appears that the opposite parties were impersonated the petitioners and registered certain documents. The complaints have been sent by post to various authorities.

Under such circumstances, the petitioners are directed to give a fresh complaint to the Deputy Commissioner of Police, Central Crime Branch, Chennai along with sufficient materials and on such complaint is being filed, the same shall be assigned to an Officer for enquiry. During the course of enquiry, if any cognizable offence is made out, the respondent police shall register the case and take action in accordance with the law laid down by the Honourable Apex Court in Lalita Kumari vs. Govt. of U.P. & others [2013 (4) Crimes 243 (SC)].

5. This Criminal Original Petition is disposed of with the above direction.

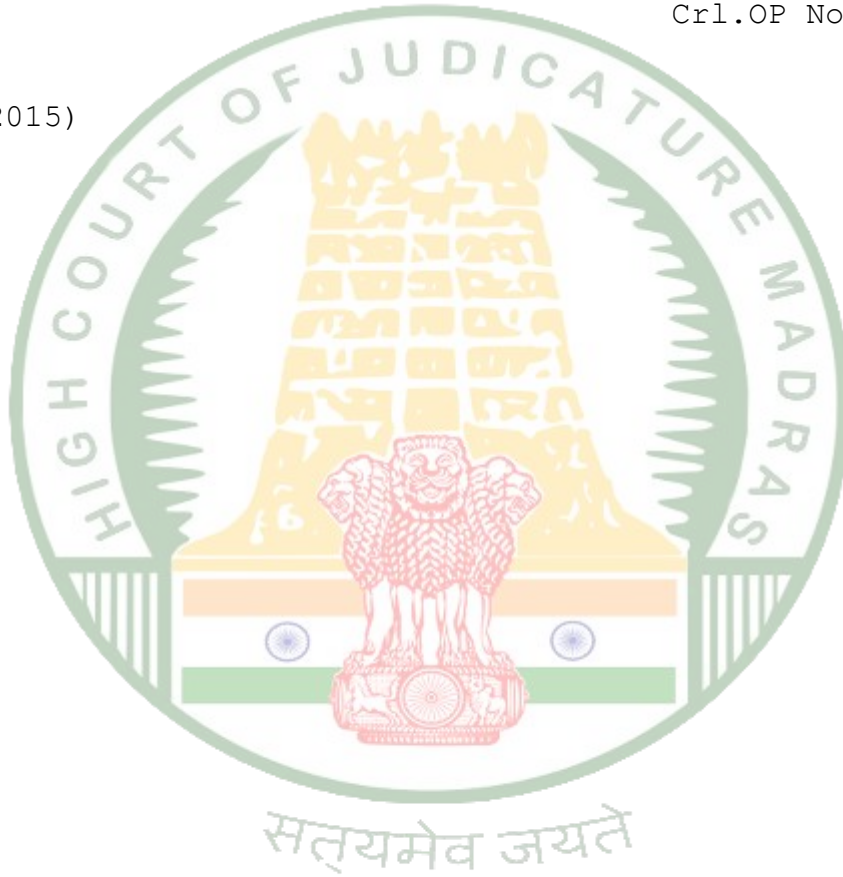
