If that is so, the petitioner is given liberty to give a fresh complaint along with supporting documents to the concerned police and on the complaint being received, the same shall be enquired into by the said police in accordance with the law laid down by the Honourable Apex Court in Lalita Kumari vs. Govt. of U.P. & others [2013 (4) Crimes 243 (SC)].
