2.The petitioner has filed this writ petition seeking for issuance of Mandamus directing the respondents directing the respondents to pass orders on the petitioner's representation dated

10.10.2012 and reminder dated 31.10.2013 for granting patta in Petitioner's name in respect of the land measuring an extent of 1.87 acres in Survey No.101/8, Agraharathazhayur Village, Sangagiri, Makudanchavadi, Salem, as directed by the District Munsif Court, Sangagiri, in its judgment and decree dated 20.07.2012 in O.S.No.238 of 2011 within a time period to be prescribed by this Court.
