Petitions presented under Article 226 of the Constitution of India, to issue a writ in the nature of the writ of Declaration, declaring that the notification issued by the 2nd respondent in the website of TANGEDCO, vide DPR/1000/TENDER/2013 in so far as the interview is concerned and the consequential selection list of 4000 Nos of Helper(Trainee) by direct recruitment 2013-2014 issued by the 1st and 2nd respondents without selecting the Petitioners are null and void, illegal and against the Boards proceedings and consequently direct the 1st and 2nd respondents to appoint the petitioners to the post of Helper(Trainee) with all attendant benefits.
