The learned Special Government Pleader fairly submits that the issue as to whether two year diploma in teacher training is equivalent to +2 (Higher Secondary) for the purpose of promotion has been considered by the State Government in G.O.Ms.No.165, School Education 3(1) Department, dated 15.10.2014, wherein it has been decided that two year diploma in teacher training acquired after 10th Standard, shall be considered as equivalent to +2 (Higher Secondary) for promotion.

2.In view of the foregoing, nothing remains for adjudication in these appeals and the writ appeals accordingly, stand disposed of. No costs. Consequently, connected MPs are closed.
