Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling upon the production of the records relating to the detention order dated 29.12.2014 made in detention order in Memo NO.2286/BDFGISSV/2014 passed by the 2nd respondent herein, quash the same and direct the respondents to produce the body or person of the petitioner's son Suresh @ Olli Suresh, son of Palli Thiruna @ Thirunavukarasu, aged about 30 years, branded as Goonda and now confined at Central Prison, Puzhal, Chennai before this Court and set him at liberty forthwith.

ORDER

The petitioner, who is mother of the detenu herein, viz., B.Suresh @ Olli Suresh, son of Palli Thiruna @ Thirunavukarasu, aged 30 years, has come forward with this petition challenging the detention order passed by the second respondent dated 29.12.2014 against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Piracy Act 1982 [Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner herein dated 29.12.2014 has been revoked by the Government in G.O. [Rt] No.1619, Home, Prohibition & Excise [X] Department dated 05.03.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
