Petition 14641/2015 to issue a Writ of Certiorarified Mandamus any other appropriate Writ or Order or Direction in the nature of Writ Calling for the records pertaining to the order passed by the 3rd Respondent in his Proceedings in Bill No.374/2015-2016 dated 13.4.2015 and quash the same and direct the Respondents to restore the power supply of the petitioner Industry at R.S.No.125/2 Pondy-Villianur Main Road Aranganoor Puducherry-607402 in consumer No.497 which was disconnected on 20.11.2014 by the 2nd respondent.
