The petitioner, who is mother of the detenu herein, viz., Keeri @ Shanmugam @ Shanmugasundaram, son of Panchatcharam, aged 34 years, has come forward with this petition challenging the detention order passed by the second respondent dated 29.12.2014 against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Piracy Act 1982 [Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner herein dated 29.12.2014 has been revoked by the Government in G.O. [Rt] No.1220, Home, Prohibition & Excise [XIII] Department dated 20.02.2015 and he has also produced a copy of the said order.

3.Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
