J U D G M E N T

(Judgment of the Court was delivered by SATISH K.AGNIHOTRI,J.,)

Questioning the legality and validity of the order dated 29/5/2013, in W.P.No.14823 of 2013, the appellants/respondents 1 and 2 have come up with this writ appeal, after a period of about two years. What the learned Single Judge has directed in the order sought to be impugned is a consideration in the light of certain Government Orders. The order must have been acted upon/implemented by this time. Thus, at this stage, we are not inclined to entertain the writ appeal. Accordingly, the writ appeal is dismissed. No costs. Consequently, M.P.No.1 of 2015 is dismissed. However, we make it clear that this order shall not create any precedent for other cases.

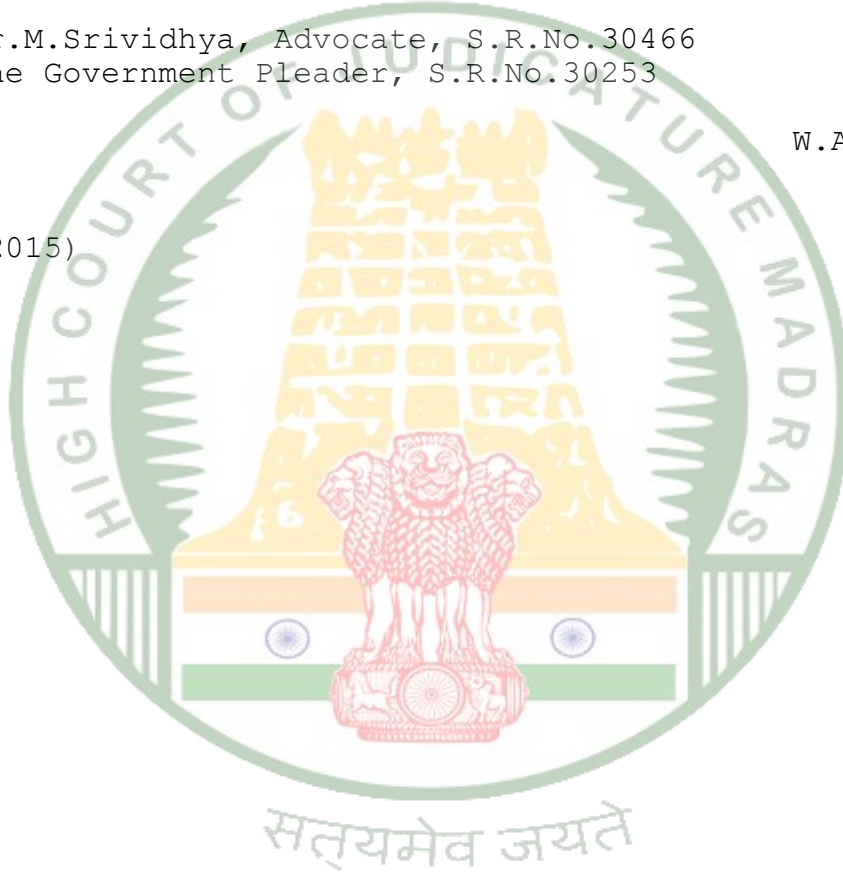
