Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling for the records in connection with the order of detention passed by the 2nd respondent dated 31.12.2014 in BCDFGISSV No.2306/2014 against the husband of the petitioner, detenu Raj @ Bun Raji, M/A 45, son of Subramani, who is confined at Central Prison, Puzhal, Chennai and to set aside the same and consequently direct the respondents to produce the detenu before this Court and set him at his liberty.

ORDER

(Order of the Court was made by S.TAMILVANAN, J.)

The petitioner, who is wife of the detenu herein, viz., Raj @ Bun Raji, M/A 45, son of Subramani, has come forward with this petition challenging the detention order passed by the second respondent dated 31.12.2014 against her husband branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Piracy Act 1982 [Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the

husband of the petitioner herein dated 31.12.2014 has been revoked by the Government in G.O. [Rt] No.1761, Home, Prohibition & Excise [X] Department dated 09.03.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
