The petitioner/detenu namely, Partha @ Paranthaman, Son of Doss, male, aged about 38 years, has come forward with this petition challenging the detention order in No.BCDFGISSSV No.09/2015, dated 07.02.2015 passed by the second respondent against his brother

branding him as a "Bootlegger" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the petitioner/detenu dated 07.02.2015 has been revoked by the Government in G.O. [Rt] No.2265, Home, Prohibition & Excise [XI] Department dated 30.03.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
