The recruitment process in pursuance to the impugned Notification stands completed. The issue pertains to 3% reservation for persons with disability with 1% for each sub-category. If vacancies are not filled up, they have to be carried forward for subsequent filling up of vacancies for such people.

3. The respondents to do the needful for the subsequent process.

4. The writ petition accordingly stands closed. No costs. Consequently, M.P. Nos. 2, 3 and 4 of 2011 are also closed.
