This writ appeal was admitted on 18.05.2011. Thereafter when this matter was listed on 13.01.2015, this Court made the following order :

" When this matter is taken up for hearing, learned counsel for the respondent/writ petitioner would submit that the order under appeal has been implemented and that the writ petitioner has been selected and appointed as Noon Meal Organiser and therefore, nothing survives for consideration in this W.A. However, the learned counsel for the appellant called absent. Therefore post the matter "For Dismissal" on 21.01.2015."

2. Today when the matter is listed under the caption "For Dismissal" neither the appellant nor the counsel for the appellant is present to adjudicate the matter or to give any information about the status of the case. If that is the position, we have no other option but to dismiss the writ appeal. Accordingly, the writ appeal is dismissed for non prosecution. Connected miscellaneous petition is also dismissed. There shall be no orders as to the costs.
