Prayer in W.P.No.10062 of 2015: Writ Petitions filed under Article 226 of the Constitution of India praying for Writs of Declaration, to declare the 1st respondent action in finalizing the tender process, without opening of the petitioner's price bid and selecting of the 2nd respondent as a successful bidder for the 14th seriatim excavation, mineral segregation, found in the Notice inviting tender, dated 10.02.2015, as illegal and is against the procedure contemplated under the provisions of the Tamil Nadu Transparency Act, 1998, and Tamil Nadu Transparency Rules, 2000.

Prayer in W.P.No.10063 of 2015: Writ Petitions filed under Article 226 of the Constitution of India praying for Writs of Mandamus, directing the respondent not to disqualify or to discard the petitioner for the seriatim 13 work, viz., (Spoil Removal Work) as found in Notice Inviting for Tender, dated 10.02.2015, on the ground that the petitioner's partner, K.Sivagnanavel is an practising advocate or that there is a reconstitution of the

petitioner firm after the date of the tender submission or any other conditions staying contrary to the General Terms and Conditions for Annual Contract, 2015-16.
