3.On reading of the complaint, it is seen that the dispute is
with regard to the change of patta by the Tahsildar in the year 2011.
If the petitioner is aggrieved over the same, he should seek for

remedy before the Revenue Divisional Officer. On the contra, a complaint has been filed in the year 2013 alleging that the Tahsildar and the Inspector of Police colluded with each other. Under such circumstances, no positive direction can be given. Hence, this petition is closed with liberty to the petitioner to work out his remedies in the manner known to law.
