The petitioner challenges the order dated 22.6.2014 on the file of third respondent, transferring the fifth respondent from Mullupatti Panchayat Union Primary School to K.Reddypalayam Panchayat Union Primary School, primarily on the ground that his candidature was not considered and the order was passed on a holiday.

When the Writ was taken up today for consideration, the third respondent, who is present in Court, produced a copy of the order dated 9.3.2015, transferring the petitioner to K.Reddypalayam Panchayat Union Primary School. In view of the subsequent order dated 9.3.2015, nothing survives for adjudication in the Writ Petition.

3. The Writ Petition is disposed of with the above observation. No costs. The connected Miscellaneous Petitions are closed.

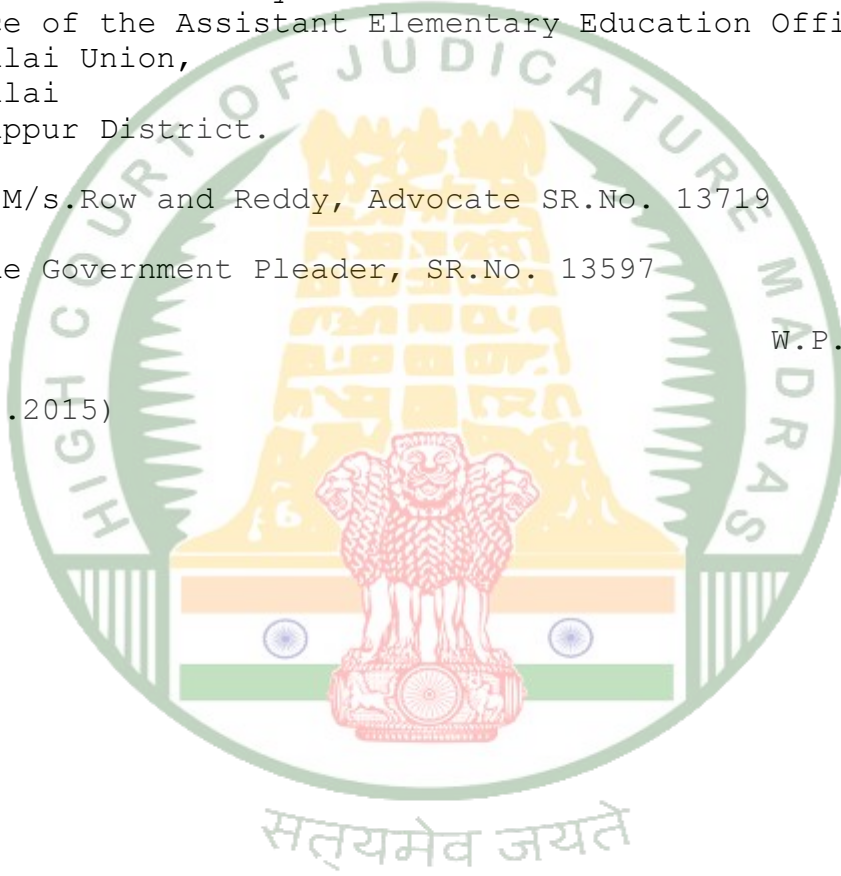
