O R D E R

The petitioner, who is the mother of the detainee, Mainavathy, wife of Sundar, aged about 28 years, has come forward with this petition challenging the detention order passed by the 2nd respondent dated 02.07.2014 against her daughter branding her as a "Bootlegger" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. It is stated by the learned counsel appearing for the petitioner that the impugned detention order dated 02.07.2014 had

been revoked. Hence, the Habeas corpus Petition has become infructuous. He has also made an endorsement to that effect.

3. Under such circumstances, the Habeas corpus petition stands dismissed as infructuous.
