Hence, this Writ Petition is disposed of with a direction to the second respondent to consider and dispose of the petitioner's representation dated 27.09.2013 and pass orders on merits and in accordance with law within a period of six weeks from the date of receipt of a copy of this order and communicate the decision to the petitioner. No costs.
