Prayer:

Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the respondents to consider the petitioner's representations dated 10.05.2007, 10.06.2009, 07.02.2013 and 13.12.2014 for issuing patta for the petitioner's land, situated at Pullurambakkam Village, Thiruvallur Taluk and District land measuring of 35 cents out of 1.62 acres in S.No.429 bounded on the East by burial Ground compound wall, West by House of Natesan and others and North by Panchayat Road, South by House of Palani.

By consent the writ petition is taken up for final disposal.

2.The petitioner submitted two representations dated 07.02.2013 and 13.12.2014 praying for patta in respect of the lands admeasuring to an extent of 35 cents out of 1.62 acres in S.No.429 in Pullurambakkam Village, Thiruvallur Taluk and District by enclosing necessary documents.
