ORDER

In view of the limited prayer made by the petitioners, without going to the merits, this Court directs the first respondent-Joint Registrar of Cooperative Societies, Cuddalore Region to consider the pending statutory revisions dated 23.3.2015 filed by the petitioners under Section 153 of the Tamil Nadu Cooperative Societies Act on merit and pass appropriate orders in accordance with law within a period of three months from the date of receipt of a copy of this order. The writ petitions are disposed of accordingly. No costs.
