2.On 28 October 2013, this Court passed the following order:

"4.Considering the above said fact, we deem it fit to direct the first respondent, either by himself or through his officials, to look into the grievance of the petitioner made on 18.12.2012 and take appropriate action in the manner known to law, after hearing the petitioner and the respondents 5 and 6, within a period of eight weeks from the date of receipt of a copy of this order. This writ petition is disposed of accordingly. Consequently, M.P.No.1 of 2013 is closed. No costs."
