"The petitioner is withdrawing the said writ petition, with liberty to take appropriate legal steps."

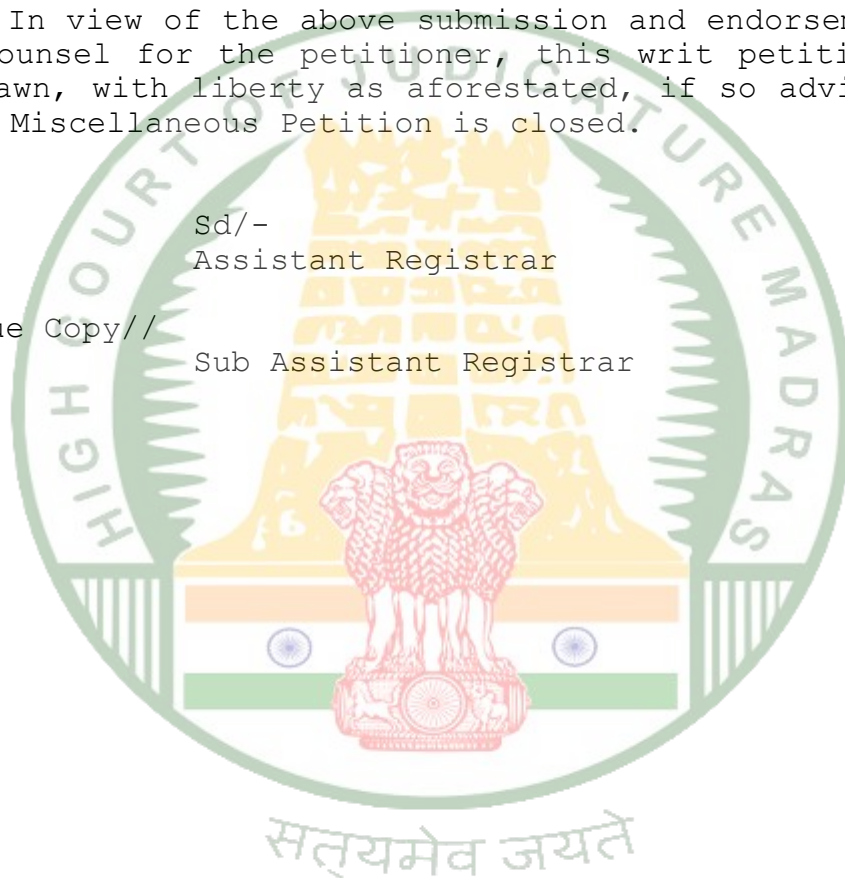

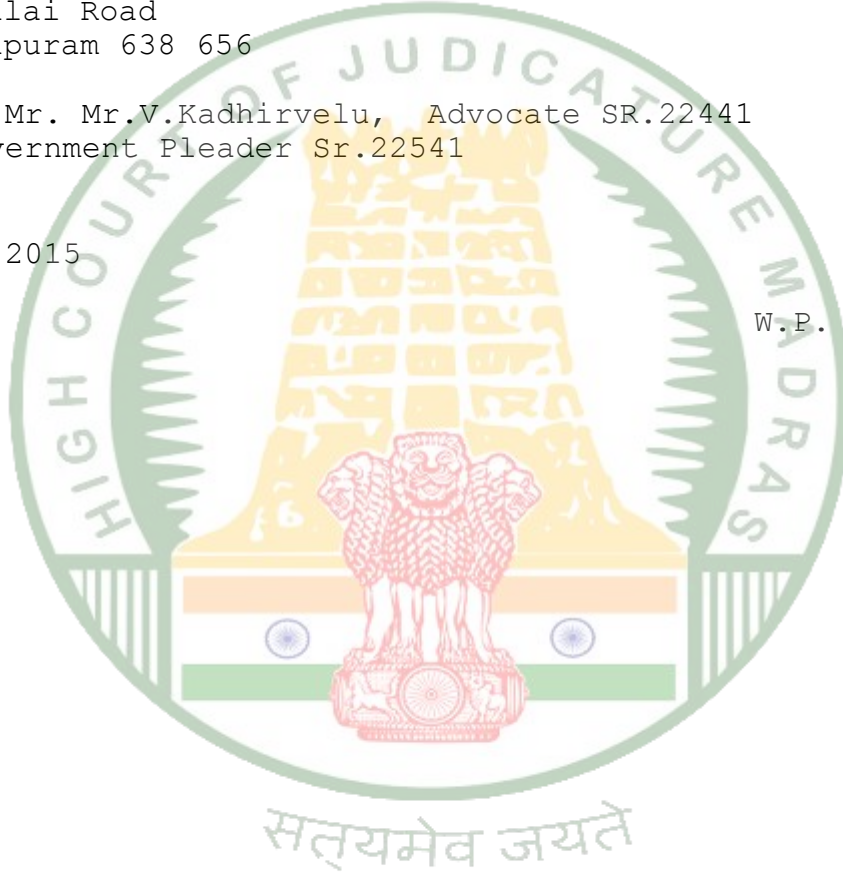
