In view of the limited prayer made during the hearing of the writ petition, the writ petition is disposed of, by directing the 2nd respondent to dispose of the representations of the petitioner dated 25.03.2015 and 20.04.2015, on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.
