3. On a reading of the complaint in Crime No.254 of 2014, serious allegations of land grabbing has been made. Despite which, no substantial progress in the investigation seems to have been done by the 5th respondent police. Taking into consideration the nature of the allegations in the FIR, this Court is of the view that, it is a fit case to transfer the investigation from the file of the 5th respondent to the file of the District Crime Branch, Kancheepuram.

The District Crime Branch, Kancheepuram is directed to continue with the investigation. The DSP Kancheepuram is directed to continue with the investigation.

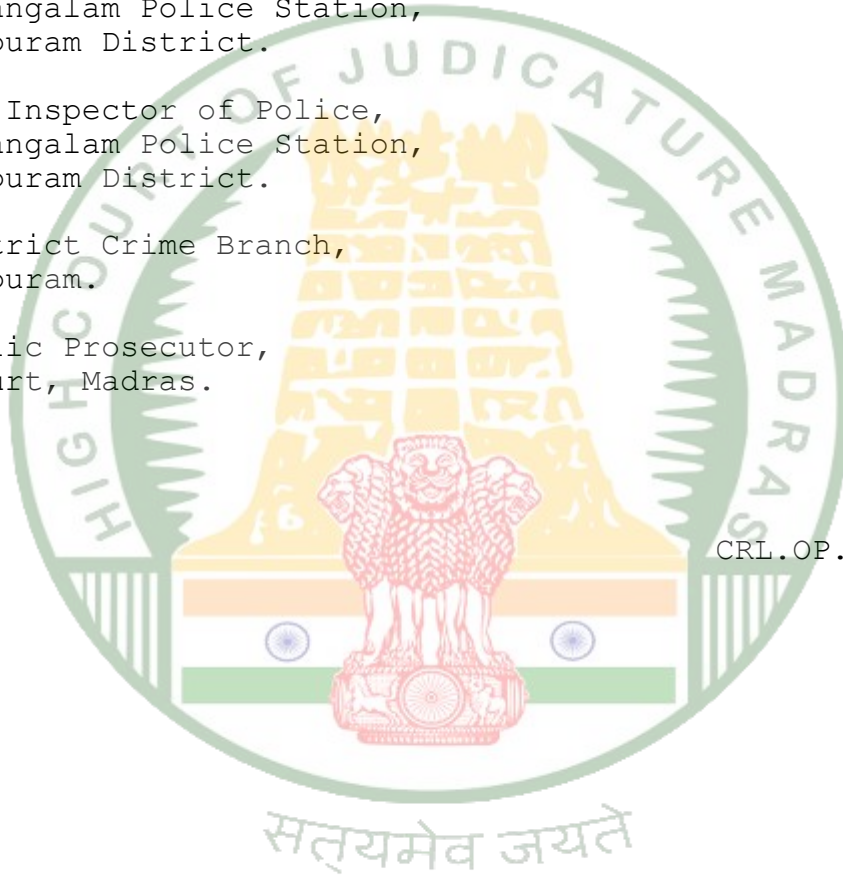
