Thus, without going into the merits of the case, a direction is issued to the first respondent to pass appropriate orders on the pending representation dated 06.10.2014 within a period of eight weeks from the date of receipt of a copy of this order. The petitioner is also directed to send a copy of the representation to the first respondent enclosing the copy of this order within a period of two weeks from the date of receipt of a copy of this order.

4. The writ petition stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.

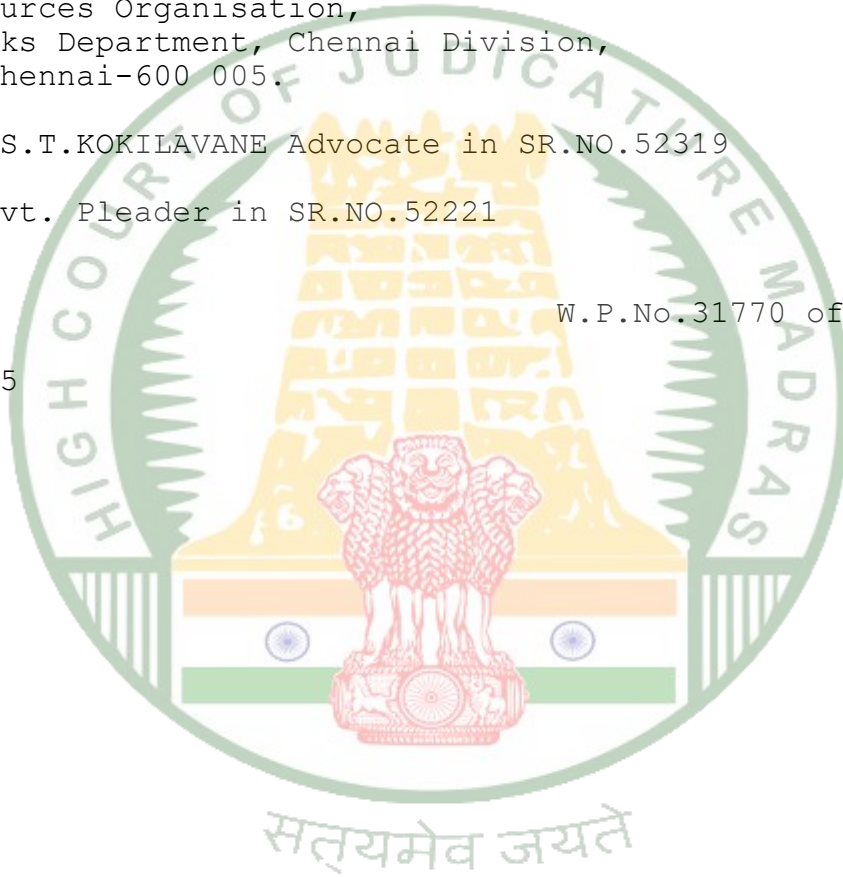
