In view of the above, a direction is hereby issued to the District Elementary Educational Officer, Theni, to send necessary proposal to the Director of Elementary Education, College Road, Chennai - 6, within a period of four weeks from the date of receipt of a copy of this order and the Director of Elementary Education, in-turn, shall send necessary papers to the Government, namely, the respondent herein, within a period of four weeks thereafter. On receipt of the same, the respondent shall pass appropriate orders within a further period four weeks thereafter.

5. With the above observations, this Contempt Petition is disposed of. No costs.

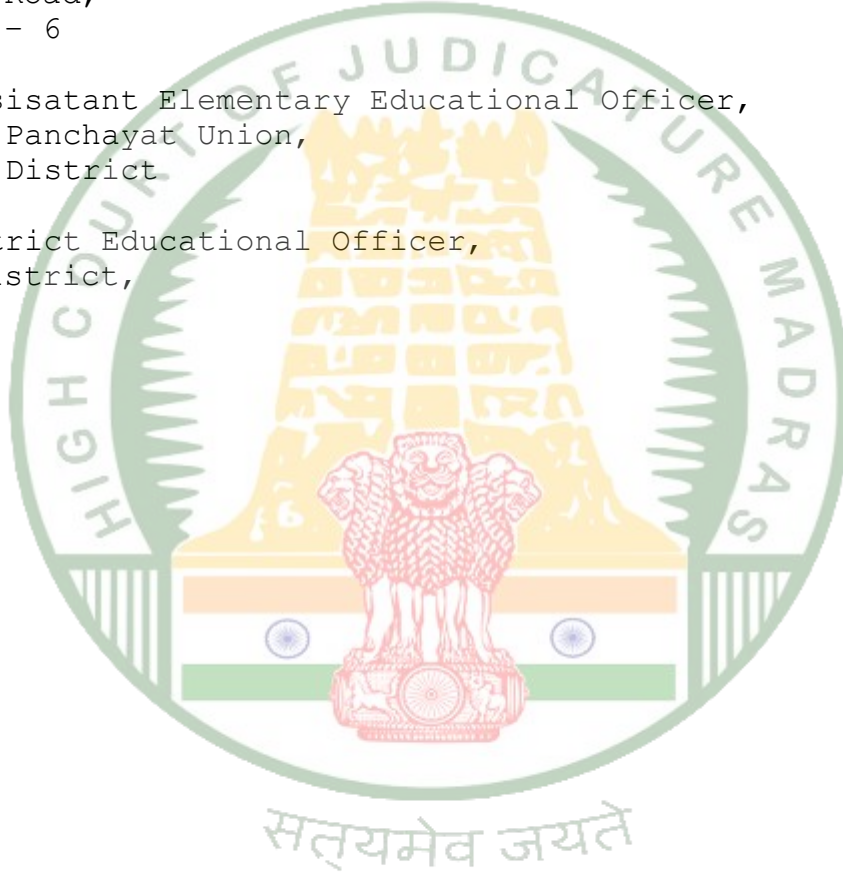
