In this connection, they were placed under suspension on 26.02.2015 by the 6th respondent in consultation with respondents 2,3, 4 and Class Faculty. According to the petitioners, the act of preventing them from attending the college would deprive them of their right to write the examination for this current trimester on the ground of absenteeism. Hence these writ petitions.
