In the circumstances, the order of the learned Principal Sessions Judge, Tiruvallur passed in Crl.M.P.No.1520 of 2015 dated 16.06.2015 is modified to the effect that the petitioner shall report before the learned Judicial Magistrate, Uthukottai daily at 10.30a.m. until further orders. Except this modification, other conditions

remain unaltered.

5. This Criminal Original Petition is disposed of accordingly.
