Heard both sides. By consent the writ petition is taken up for final disposal.

2.The petitioner is a Secondary Grade Teacher. He has acquired M.Phil qualification. He has sought for incentive for acquiring the said qualification. He has made a representation dated 12.01.2015 to the third respondent seeking to grant him incentive increment for the said qualification.

3.The learned counsel for the petitioner also relied on a judgment of the Hon'ble Bench of this Court made in W.A.(MD) No.131 of 2014 dated 18.12.2014 and prayed for the aforesaid relief.

4.In view of the narrow prayer made, the writ petition is disposed of, directing the third respondent to pass orders on the representation of the petitioner dated 12.01.2015 for incentive increment for acquiring M.Phil qualification in the light of the judgment of the Hon'ble Bench of this Court made in W.A.(MD) No.131 of 2014 dated 18.12.2014, within a period of eight weeks from the date of receipt of a copy of this order.
