Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling for the records relating to the detention order No.1688/BDFGISSSV/2014 dated 04.11.2014 passed by the second respondent under the Tamil Nadu Act 14/1982 and quash the same and produce the detenu Udhayakumar, Son of Krishnakumar, aged about 25 years, before this Court and set him at liberty.

ORDER

The petitioner, who is father of the detenu herein, viz., Udhaya Kumar, son of Krishnakumar, aged about 25 years, has come forward with this petition challenging the detention order passed by the second respondent dated 04.11.2014 against his son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Piracy Act 1982 [Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner herein dated 04.11.2014 has

been revoked by the Government in G.O. [Rt] No.7181, Home, Prohibition & Excise [XIII] Department dated 22.12.2014 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
