ORDER

The petitioner, through proper channel, submitted a representation to the third respondent to post him in Tamil Nadu. However, the representation was not taken up for consideration by the third respondent. The petitioner is therefore before this Court.

2. The third respondent is directed to consider and dispose of the representation submitted by the petitioner, dated 13.10.2014, taking into account the fact that he is due to retire on 31.07.2017 and his family condition, including the necessity to give his daughters in marriage. Such exercise shall be completed within a period of four weeks from the date of receipt of a copy of this order.

3. The writ petition is disposed of with the above direction. No costs.

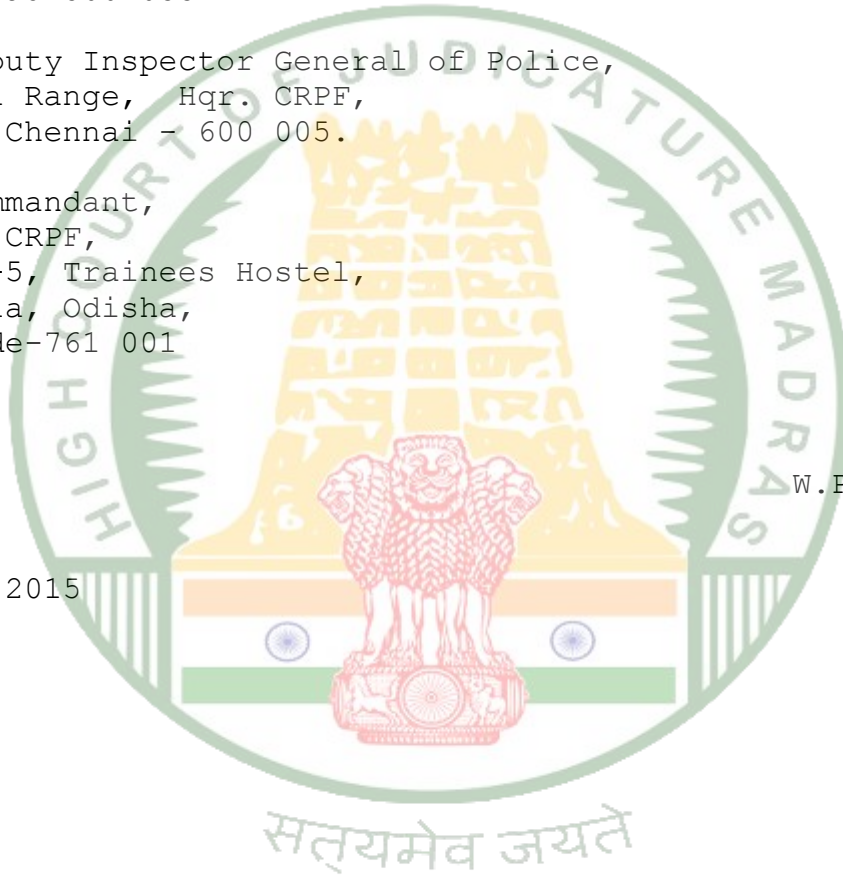
