respondent. The petitioners have submitted a representation dated 19.11.2014 requesting the 1st respondent to rectify the mistakes pointed out by them and fix the pay scale in accordance with the recommendation of VI Pay Commission. The present request is to direct the 1st respondent to consider and dispose of the representation of the petitioners dated 19.11.2014.

The 1st respondent is directed to consider and dispose of the representation submitted by the petitioners dated 19.11.2014 on merits and as per law, more particularly in the light of the recommendation made by the VI Pay Commission. Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.
