Habeas Corpus Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of Habeas Corpus directing the detaining authority to produce the detenu, the petitioner's son Baskar, S/o.Janikaraman, aged about 25 years, a resident of No.2, Karuneegar Street, Nerkundram, Chennai-600 107, in the matter of detention order Act 14 of 1982 after having been declared as a Goonda by preventive detention order dated 15.11.2014 in BDFGISSV No.1838 of 2014 and presently confined at the Central Prison, Puzhal, Chennai and to quash the same and to set aside the same and to set the detenu at liberty.

The petitioner, who is the mother of the detenu Baskar, S/o.Janikaraman, aged about 25 years, has come forward with this petition challenging the detention order in BDFGISSV No.1838 of 2014 dated 15.11.2014 passed by the second respondent against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit

that the order of detention passed by the second respondent as against the son of the petitioner dated 15.11.2014 has been revoked by the Government in G.O. [Rt] No.178, Home, Prohibition & Excise [XIII] Department dated 09.01.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
