3. Heard the submissions made by Mr.N.Ananda Kumar, learned counsel for the petitioner and Mr.S.Pattabiraman, learned Government Advocate who accepts notice for the respondents.

This Court, without going into the merits of the application/representation, directs the 2nd respondent to consider and dispose of the petitioner's application/representation dated 16.05.2015 in accordance with law and pass orders on or before 12.06.2015 and communicate the decision to the petitioner.

Accordingly, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
