Today, when the matter is taken up for hearing, Mr.R.Govindasamy, the learned Additional Government Pleader appearing for the respondent placing on record a letter dated 28.01.2015 issued by the Director-in-charge, Forensic Sciences Department, submitted that in superseding the impugned seniority list, the Director of Forensic Sciences Department during 2006 issued revised seniority list vide proceeding No.A1/42200/2006 OO No.190 and 191/2006 dt.09.10.2006 and A1/42200/2006 OO No.194/2006 dt. 25.10.2006 and the same has been upheld by the Division Bench of this Court in its common order passed in W.P.No.12751 of 2004 and 23 others dated 28.01.2009 and hence, nothing survives in the writ petition.
