Habeas Corpus Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of Habeas Corpus to call for the records and to quash the same relating to the detention of the petitioner's son namely Ramesh @ Satchi Ramesh, son of Damotharan, aged 28 years, detained under Act 14/82 vide detention order dated 01.12.2014 on the file of the second respondent herein made in Memo No.2044/BDFGISSV/2014 and consequently direct the respondents herein to produce the body and person of the said detenu before this Court and thereafter set him at liberty from Central Prison, Puzhal, Chennai.

ORDER

The petitioner, who is the mother of the detenu Ramesh @ Satchi Ramesh, son of Damotharan, aged 28 years, has come forward with this petition challenging the detention order in Memo No.2044/BDFGISSV/2014, dated 01.12.2014 passed by the second respondent against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug

Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner dated 01.12.2014 has been revoked by the Government in G.O. [Rt] No.1102, Home, Prohibition & Excise [XIII] Department dated 16.02.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
