2. On 24.07.2015, this Court had passed final orders on the premise that, regular case is registered in Crime No.103 of 2015. Today (i.e, on 21.08.2015), it is brought to the notice of this Court that, no regular case was registered, only petition enquiry in C.S.R.No.103 of 2015 is pending. Hence, the order dated 24.07.2015 is hereby recalled and the paragraphs 3 & 4 of the said order, shall stand replaced as under:
