PRAYER: Writ Petition filed under Article 226 of Constitution of India praying to issue Writ of mandamus to direct the respondents to consider the petitioner's representation dated 15.05.2014 and allot a alternative Bunk Shop in his name in lieu of cancelled Bunk Shop No.71, measuring 50 sq.ft. which was allotted in his name bearing No.P2/16925/2003, dated 19.09.2003 by the respondents in between 27th and 29th cross street in T.P.Chathiram Main Road, Chennai - 30.

The petitioner made a representation on 15.05.2014 seeking allotment of a Bunk Shop alternatively in view of the cancellation of earlier one. As the said request was not considered, the present writ petition has been filed.

2. Learned counsel appearing for the petitioner has produced a letter dated 08.09.2015 issued by the first respondent, in which, it is stated that the request of the petitioner would be considered after the disposal of the writ petition.

Considering the above, a direction is issued to the first respondent to look into the grievance of the petitioner as per his representation dated 15.05.2014 and pass appropriate orders on the same within a period of six weeks from the date of receipt of a copy of this order in the light of the letter referred above. With this direction, the writ petition stands disposed of. No Costs. M.P.No.1 of 2014 is closed.
