Prayer: Writ Petition is filed under Article 226 of the Constitution of India praying for issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the impugned order in G.O.(3D) No.12, Adi-Dravidar and Tribal Welfare (LA2) Department dated 30.04.2013 passed by the first respondent and quash the same; consequently, direct the respondents 1 to 5 to issue house site patta to the petitioners, in the lands comprised in Survey Nos.59/2B, 59/3B, 59/4A1, 59/4, 89/1A and 59/4C etc. (Originally Survey No.59) in karipatti Village in Valapady Taluk in Salem District, as per the original acquisition covered in Award in No.16/79-80 dated 25.03.1989, within a reasonable time to be fixed by this Court.

O R D E R
