4. The writ petition accordingly stands disposed of. No costs. Consequently, M.P.Nos.1 and 2 of 2015 are closed.

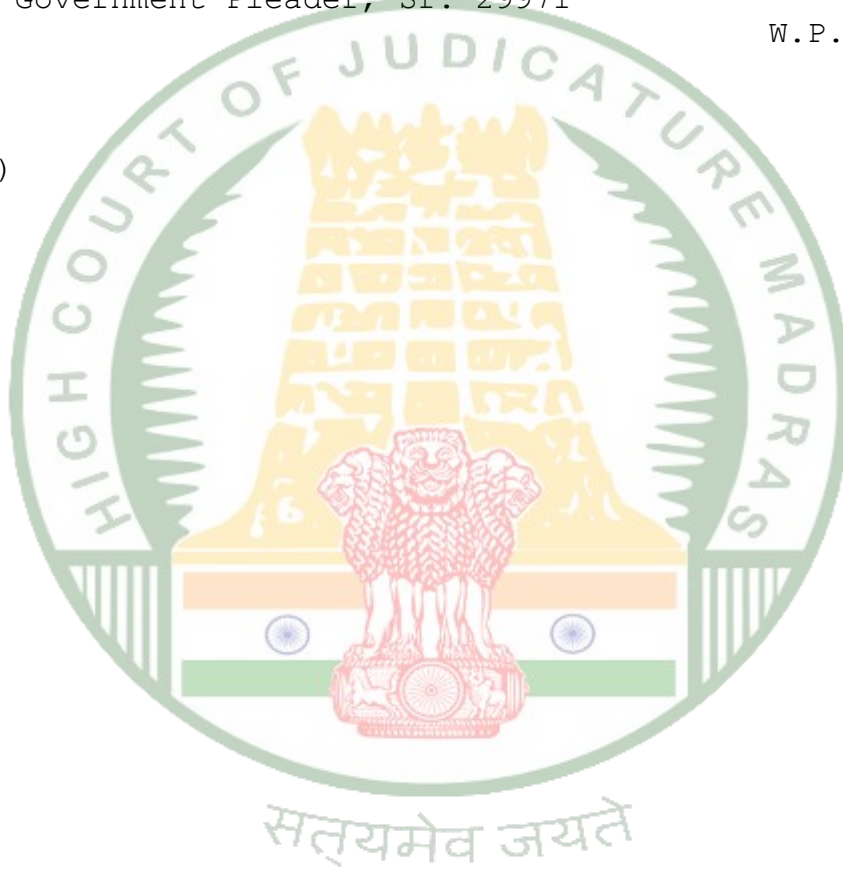
