PRAYER: Writ Petition filed under Article 226 of the Constitution of India for the issuance of a Writ of Mandamus to direct the respondent to give permission to the petitioner to conduct a cultural program scheduled to be held on 25.06.2015 in Gangai Amman Temple There festival at Alichkulam, Devasthanam Post, Vaniyambaddi, Vellore District by considering the petitioner's representation dated 10.06.2015.

ORDER

By consent of the learned counsel appearing on either side, the writ petition is taken up for final disposal at the admission stage itself.

2. The petitioner claims to be the organiser of the Gangai Amman Temple There festival at Alichkulam, Devasthanam Post, Vaniyambaddi, Vellore District. He submitted a representation dated 10.6.2015 to the respondent seeking permission to conduct a cultural programme in the temple festival, which includes song and dance programme to be held on 25.6.2015. Since the petitioner has not been favoured with any response, he came forward before this Court with the present writ petition.

3. Learned counsel appearing for the petitioner submits that in the event of permission granted by the respondent, there would not be any law and order problem and obscenity and vulgarity will not be there and prays for appropriate orders.

4. Heard the submissions of Mrs.P.Rajalakshmi, Government Advocate, who accepts notice on behalf of the respondent.

5. This Court, in the facts and circumstances of the case, without going into the merits of the representation dated 10.6.2015 made by the petitioner, directs the respondent to consider the petitioner's representation dated 10.6.2015 and pass orders in accordance with law on or before 23.6.2015 and the respondent shall also communicate the decision taken to the petitioner.

6. The writ petition is disposed of accordingly. However, there is no order as to costs.
