ORDER

The petitioner was appointed as a Junior Assistant in the 5th respondent school on 01.10.2007. The 2nd respondent granted permission to fill up the post on 04.01.2010. While so, the 4th respondent granted approval for appointment from 12.01.2010 by his order dated 26.03.2010. In this regard, the petitioner submitted a representation dated 31.07.2014 to the respondents for the grant of approval from the date of his appointment. Now, the grievance of the petitioner is that his representation has not so far been considered. Hence, he has come forward with this writ petition seeking appropriate direction to the 4th respondent to consider his representation in the light of the order dated 08.06.2012 made in W.P.No.10325 of 2012 [M.Sekar v. The Government of Tamil Nadu, Rep. By its Secretary, Department of School Education, Chennai and others].

2. I have heard the submissions made on either side.

3. In view of the narrow prayer made, the 4th respondent is directed to consider the representation made by the petitioner on 31.07.2014 in the light of the judgement referred to above and pass appropriate orders within a period of twelve weeks from the date of receipt of a copy of this order. No costs. Consequently, connected MP is closed.
