COMMON ORDER

The petitioners were working as Clerk and Accountant, respectively, in the second respondent Co-operative Society. In these writ petitions they seek for a direction to the respondent/Co-operative Society to furnish them the relevant documents for the purpose of defending the disciplinary proceedings.

I am of the view that the writ petitions are not maintainable against co-operative society in view of the larger Bench Judgement of this Court in the case of Marappan vs. Deputy Registrar of Co-operative Societies, Namakkal, reported in 2006(4) CTC 689. Hence, the writ petitions will stand dismissed. However, this will not prevent the petitioners from seeking such remedy which are open to them under law. No costs. Consequently connected miscellaneous petitions are dismissed.
